Instructions

Section 1- Horse Information:

- 1. Write in your 1st and 2nd Name Choices for this horse. Be sure the name begins with the letters issued each year for the year of birth.
- 2. Write in the horse's Date of Birth, Gender, Color and White Markings. If no markings write NONE.
- 3. Note any other distinguishing marks such as brands or scars by drawing the brand and giving its location.

<u>Section 2 – Breeding Certificate:</u>

- 1. This section must be filled out and must match the Stallion report filed for that breeding year.
- 2. The Breeder is the owner of the DAM at the time of breeding.
- 3. Write in the full, registered name of the DAM and give her Registry Number.
- 4. Write in the name and address of the owner of the SIRE at the time of breeding.
- 5. Write in the full, registered name of the SIRE and give his Registry Number.
- 6. The BREEDER and STALLION OWNER must sign.
- 7. Include a copy of the registration papers of the sire & dam if they are not registered with the Canadian Friesian Horse Association.

Section 3 – Original Owner of the horse:

Complete name, address, and other information of the original owner of the horse at the time of birth. If the current owner is not the same as Breeder, you must include a copy of the bill of sale or sale agreement to show legal ownership of the Dam and/or Foal at the time of birth. The original owner must sign this section.

<u>Section 4 - Current Owner of the horse (Transfer of Ownership)</u>

Complete this section if the current owner is not the original owner. This section must be signed by the original owner and current owner. The horse will be registered in the current owner's name with no transfer fee.

Section 5 – DNA Parentage Verification

All horses must be DNA profiled and the Friesian parentage must be verified. Provide a copy of DNA reports when available. If the report is not available, request a kit in this section. All horses must be microchipped, supply the microchip number or request a microchip.

Section 6 - Markings

Carefully, and as accurately as possible, draw in the WHITE markings of the horse being registered. Include permanent scars. Show all hair whorls with an "X" where they appear. Draw all brands as and where they appear. Be sure that the drawn markings match the written description on Page 1, Section I. Use the examples shown to determine the correct written terminology.
